Special invitations have been extended to nearly 40 REA Board Members who have served us in the past. Come by to renew some old acquaintances and make some new ones!



SDCERS Board Trustee Representative Election –


Postmark on mailed envelope required by September 2, 2016.

The Tuesday, SEPTEMBER 13, 2016 Monthly REA meeting is in the WAR MEMORIAL BUILDING, at the north end of the Zoo parking lot. Richard is the author of more than 50 books about language, history, and humor, including his best-selling *Anguished English* series and his current books, *Amazing Words, Lederer on Language,* and *Monsters Unchained!* Dr. Lederer's column "Lederer on Language" appears weekly in the *San Diego Union-Tribune,* and he is a founding co-host of "A Way With Words" on KPBS Public Radio. He has been named International Punster of the Year and Toastmasters International's Golden Gavel winner.

ADVOCACY - Reported by Mike Bresnahan

Meetings are scheduled for fourth Thursdays – September 22, and October 27, 2016. Issues discussed are health care plans, potential changes, and options. All meetings are in the Mission Valley Library (in a conference room on the west side in the library) from 9:30 AM to 11:15 AM.

August 9, 2016 General Meeting Minutes: Reported by Brad Jacobsen

The Minutes of the July 2016 meeting and the July 2016 Treasurer's Report were approved.

Jessica Packard of SDCERS reported that the election material for the vacancy on the CERS Board will arrive in mailboxes shortly. Members will have from August 22 to September 2 to vote. Due to technical problems, phone voting will not be available; mail-in ballots must be postmarked by midnight September 2. Online voting will be available soon.

Jim Baross announced that the REA Board has voted to endorse Chris Brewster for the vacancy on the SDCERS Board.

Mike Bresnahan announced that the Advocacy Committee is investigating possible insurance plans for REA members. Plans could cover dental, vision, travel, and pet insurance. Mary Ann Stepnowsky reminded members that the September 13 meeting will be the 50th anniversary of REA's founding and we will have a wonderful celebratory party.

PROGRAM

The program was Dr. Todd Coleman of UCSD speaking about future innovations in healthcare. Coleman is an MIT-educated engineer who is working at UCSD to develop electronic patches that can be taped to a patient's body. These patches will transmit the patient's vital signs – including sleep patterns – directly to the nurses' station, eliminating the need for cumbersome wires and electrodes. The patches can also be used to monitor the possible development of symptoms of Fetal Alcohol Syndrome in infants as young as six months and to remotely track physical therapy exercises for frequency and correctness; the latter is especially important for stroke-recovery patients who have trouble swallowing. Dr. Coleman also addressed privacy issues, noting that data collected by the patches can be downloaded onto the patient's smart watch instead of being transmitted to the medical professional.

Volunteer Opportunity:

At the San Diego Zoo Safari Park, volunteers play an active role in the organization and help make a difference for wildlife. Volunteers benefit by working in a fun and engaging environment, making new friends, and being out-of-doors. In addition, they receive unlimited entry to both the Safari Park and San Diego Zoo, and other perks based on the number of hours they volunteer.

We, retired City of San Diego employees, have been recommended as retirees who would make excellent volunteer candidates. This award winning program is currently recruiting new volunteers. Minimum requirements include being 18 years old and willing to give 60 hours a year of your time on order to help save animals from extinction. Active volunteers receive great perks and continuing education opportunities.
