<u>ADVOCACY</u> - Mike Bresnahan Reporting

I wanted to take a moment and let you know of a few things the Advocacy Committee has been working on. We crafted a letter to SDCERS concerning the appointment of their new CEO. As you may know Mr. Mark Hovey is retiring and the Board thought it appropriate to provide input to SDCERS concerning issues it thinks are important. Our letter to SDCERS stressed two points; first, the new CEO should continue the effort of Mark and his staff to maintain a good working relationship with REA and the other retiree organizations representing retired city employees. Second, we encouraged the new CEO to be proactive in advocating on behalf of SDCERS and retired employees with the plan sponsor, the media and general public. This letter will be distributed to all SDCERS Board members prior to the selection of the new CEO.

We have also begun the process of updating and we think improving our WEB site. This process will take some time but when completed you should see a better product. There are a number of people from the Advocacy Committee contributing their time, but Mary Ann Stepnowsky in particular is doing great work on this effort.

Second and Final Announcement of Notice of

LAWSUIT TO COLLECT UNDERPAID OVERTIME THE CITY MAY OWE YOU

For Retired Employees Association (REA) members who have recently retired, if the City paid you "time and a half" overtime for working more than forty (40) hours during a seven-day week at any time in the PAST THREE YEARS -- while you were also participating in the City's Flexible Benefits Plan - it is likely that the City has underpaid you for your overtime work.

The City has known for a long time that it was underpaying overtime by using the wrong overtime rate. In fact, the City sent an email to current employees to say that this underpayment problem was fixed as of July 1, 2017. But the City has said nothing about paying what current or retired employees are owed for past underpayments. With each day that passes, the City's liability for past underpayment overtime is reduced because the statute of limitations on claims is running. This is why MEA has filed a case to assure that every Municipal Employee Association (MEA) represented employee who has a claim has the opportunity to join to protect his or her rights to full payment. MEA has now agreed to allow affected REA members to also join this suit. If you choose to join, MEA will pay the fees and costs to file and litigate this lawsuit. MEA will also provide critical staff support to facilitate the communication and completion of necessary paperwork. Once you complete and return the paperwork required of you, your work is done.

Using your private email account - not City email - notify Nichole Johnson at MEA that you want to join the lawsuit. Send an email to njohnson@sdmea.org giving her your name. Nichole will send you documents to your private email which you

Retirement Report from Charlie Hogquist: The 13th check and Corbett payments should be in the November pension checks (Friday December 1, 2017). Also, the first round of selections for the new SDCERS CEO has been completed. The SDCERS board hopes to announce the new CEO at the JANUARY BOARD MEETING.

Report on Old Globe Tour by Joan McNamara:

On November 13th, forty-three members attended REA's behind the scenes tour of The Old Globe theater in Balboa Park. Everyone had a wonderful time.

NOVEMBER GENERAL MINUTES - Reported by Brad Jacobsen

The minutes for the October 2017 meeting and the October Treasurer's Report were approved.

Jim Baross presented a slate of Board members running for re-election; there were no nominations from the floor. **M/S/C** to Elect Jim Baross as President; Dave Twomey as Vice-President for Programs; Mike Bresnahan as Vice-President for Advocacy; and Shirley Hall and Joan McNamara as Directors.

Jessica Packard of SDCERS reported that the Board approved issuing both the 13th Check and the Corbett check as part of the November pension payment. She also reported that video of the Annual Meeting has been posted on the SDCERS website.

Joan McNamara gave a summary of the Old Globe tour on November 13. Another activity is being planned, probably for February.

Mike Bresnahan reminded members about the lawsuit MEA is filing on behalf of employees and recent retirees whose overtime pay was miscalculated. He stressed that this is not a class action lawsuit; those affected must contact MEA to be included or benefit from the suit.

PROGRAM

The program was our annual visit from Carl Luna, political science professor at Mesa College. Dr Luna spoke about general political and economic trends in the country. He noted that these trends do not bode well for us as a nation that we are in danger of becoming run by corporations. In fact, *The Economist* has already declared that the US is no longer a "full democracy" because of the lack of power of the common citizenry. Finally, he warned that the current and future level of income disparity is pushing us into a feudal society.

Last newsletter we said Nov. 3, 2017 would be Mark Hovey's last Board meeting.
