MESSAGE FROM PRESIDENT JIM BAROSS -

What a resourceful group you have supporting REA! Several people deserve some thank yous for stepping up to fill in when our scheduled General Membership Meeting speaker could not attend. Mary Ann Stepnowsky, John Tsiknas, Chris Brewster, and Jessica Packard from SDCERS provided our replacement program, *Internet for Retirees*. After an overview of the SDCERS website, laptops were deployed at several stations showing and explaining of to use the REA website, the REA Facebook page, the SDCERS website, and how to use Twitter - so that you too can get Tweets directly from the President of the United States! We helped several retirees to be more comfortable with using the resources of the Internet.

Notice about proposed Bylaw change: We are calling for a vote, at the May 9, 2017 General Meeting to get it officially done. The REA Board is recommending a Bylaw change. The Board considers that new text to more accurately explain the quorum requirements (officers are board members).

Proposed new for Rules of Order, Rule III, Quorum, Section 1 - *"Eight Board members, of which at least two must be officers, shall constitute a quorum at any meeting of the Board of Directors."*

PROPOSITION B - UPDATE April 2017:

As you may have read or heard on Tuesday April 11, 2017, the 4th District Court Of Appeals reversed a decision by PERB that had ruled that the passage of Proposition B was illegal. Remember, Prop B replaced the city's defined benefit pension with a 401k program for all new city workers except for police officers. PERB had decided that Proposition B needed some negotiation with the city labor unions because of the mayor's involvement on the passage of Prop B. The proponents of Prop B declared it to be a Citizens' Initiative thus not needing labor union discussions.

The Fourth District Court ruled that Prop B was a Citizens' Initiative and that while the mayor's office supported that effort, that support did not require consultation with the unions. The next step in this process could of an appeal of the District Court's decision to the State Supreme Court. We will know shortly if this appeal will proceed. This decision leaves the City of San Diego as the only jurisdiction in California without a defined benefit program for all of its employees.

PUBLIC SAFETY NOTEBOOK - SAN DIEGO 'Can you hear me?' phone scams on rise.

Let's call the automated voice on the phone "the headset lady." She asks, "Can you hear me?" and feigns some sort of malfunction with her headset. If you answer "yes," you can fall victim to one of the newer incarnations of phone scams targeting people across the U.S. She sounds pretty real at first, so people tend to respond. What should you do if she calls? Hang up, the Federal Communications Commission says.

These scams are designed to record your affirmative response to obtain a "voice signature," and can later be used to authorize unwanted charges for products or services on a phone, utility or credit card account. How can you get charged if you don't provide other personal information, such as credit card information? The con artists may already have it— as a result, for example, of a data breach. If there's an objection to the charges, the scammers can play back the recorded "yes" to intimidate the victim to pay up. In San Diego County, 60 people since Jan. 27 have reported to the Better Business Bureau a suspicious call from someone who asked, "Can you hear me?" Plenty responded with a "yes," according to the reports submitted through the organization's website. Several people in the county said the caller, this time male, introduced himself as Josh, from an unidentified company's customer service department. "First thing he asked was, 'Can you hear me?" a Lakeside- area resident wrote in a report. "Before I realized it, I said, 'Yes.' Many more said the caller was someone who claimed to have trouble with a headset.

The latest report in the county was submitted week ago by a Ramona-area resident. At a national level, the Better Business Bureau has logged 8,500 reports of similar calls since January 2017. Of those, more than 500 were reported in California. Although the reports across the U.S. seem to continue, there have been no reports of specific instances in which someone was swindled. Still, if you have gotten this type of call, the FCC suggests you check your bank statements and other bills for unfamiliar charges.
